CIRCULAR

In accordance to para 8.1 of the Operational Guidelines of the Ministry of Youth Affairs and Sports Government of India, F.No.54-1/MYAS/MDSD/2017, Dt. 26.12.2017, removal (including temporary discontinuous) of the players from the scheme is done after the performance assessment of Khelo India Athletes (KIAs) by the Talent Identification and Development Committee (TIDC).


2. In this regard, all concerned are hereby informed through this notice regarding the removal of athletes of Sports discipline of **Football** from Khelo India Scheme on the basis of recommendation of the Talent Identification and Development Committee (**Football**). These athletes henceforth shall not be treated as part of Khelo India Scheme, and all the other ancillary expenses including services extended under Khelo India Scheme shall be withdrawn with effect from **30.09.2023**.
