

Induction/Weedout Criteria – Swimming

The TIDC concurred with following proposed induction/weeding out criteria for Next year (Apr 2023 – Mar 2024).

- A. Competition to be considered for talent identification for induction as NCOE athletes:
- SFI Junior National Championships.
 - SFI Senior National Championship
 - Khelo India Youth Games
- B. Performance Analysis of Existing NCOE & KIA's:
Performance will be analysed through below mention competition based on the Yearly Best Performance in the Main Events of a Swimmer out of following Meet: -
- a. SFI Junior National Championships.
 - b. SFI Senior National Championship.
 - c. National Games.
 - d. FINA recognize international meet
 - e. Khelo India Youth Games
 - f. Khelo India University Games
- C. Technical, Scientific and Sports Science Evaluation:
As per Khelo India Approved Test Protocols
- D. Benchmark:
Induction Benchmark for KIA:
- i. Athlete must attain decided minimum FINA points (Refer Table below) for induction along with Gold, Silver & Bronze medal.
 - ii. If there is a tie in FINA Points then medal ranking will be considered.
 - iii. If there is again a tie then a younger athlete will be preferred for induction in Khelo India Scheme.
 - iv. From below mentioned competitions best performance will be selected for KIA induction post discussing with TIDC members.
 - SFI Junior National Championships.
 - Khelo India Youth Games
 - SGFI

Weeding out Benchmark for KIA:

For weeding out, if KIA have **NOT** achieved **6th Place or below**, in any of the events mentioned below of either of **last Two (02) year's competition** shall be taken into consideration **(if a swimmer did not manage of participate in any Nationals mentioned below for a "justified reason", then his/ her timings in any other Major Events will be compared against 6th Place in the below mentioned nationals)**. Following competition will be considered for assessment:

- a. SFI Junior National Championships.
- b. SFI Senior National Championship.
- c. National Games.

Weeding out Benchmark for NCOE:

Weeding out Policy Proposed is as follows (Any of the following, subject to Swimmers have completed 2 years of training in NCOE): -

1. If a Swimmers did not manage to swim at the Min Time Criteria (Detailed Time Chart Enclosed) in any of the Major Long Course Swimming Meet (where touch PAD is used for time) in relevant Financial Year "in any event" in any of the major "Long Course" meet (where touch PAD is used for time) in the Fin. Year 2022-23.
(However, if a swimmers achieve Top 3 Positions in any Individual Events in Senior, Junior or Sub-Jr. Conducted by SFI, may be considered for continuation even did not achieve the time criteria)
** Timing Chart is enclosed along with (Understanding Indian Female Swimming Standard is lower compare to male in international level, Fina Point Criteria for Female has been Lowered.)
2. Disciplinary Ground – Indiscipline, long absence, irregular in training. The NCOE has to submit the warning letters, issued to athletes regarding the same, to the KITD Department and accordingly recommended list of athletes to be weeded out with justification.
3. If Improvement is less than 1.5% (Under 18 yrs.) and 1% (for 18+yr) either of the last two consecutive year (i.e., 2022-23 or 2023-24)
